

Child Safeguarding

Child safeguarding is the responsibility that organizations have to <u>make sure</u> their staff, operations, and programmes do no harm to children, and they <u>do not expose</u> <u>children/beneficairies</u> to the risk of harm and abuse, and that any concerns the organization has about children's safety, within the communities in which they work, <u>are reported</u> to the appropriate authorities.(KCS)




