ACTIVITIES AND RESULTS

According to the objectives of <u>Strategy 2020-2025</u>, the Network is focusing its work during this period on establishing the Network as a sustainable and formidable entity, and supporting network members to expand and institutionalise Barnahus in their countries.

The following is a summary of the year's work to achieving these objectives, presented using the framework of the Network's <u>strategy</u>.

DEVELOPMENT

NEW MEMBER APPROVALS

4 new members were onboarded during the year. Targeted outreach was conducted to generate new membership applications. For details see the membership lists in the introduction to this annual report.

Membership applications are accepted and reviewed on a rolling basis.

Definition - includes the recruitment of members, champions and observers. It also covers internal network activities, including steering group meetings, annual work plans, quality control and reporting.

Purpose - Making it easy and attractive for the right actors to join and be active in the Network, as well as ensuring transparency and quality in the administration.

MEETINGS AND DECISIONS OF THE STEERING GROUP AND GENERAL ASSEMBLY

Steering Group, 13 February 2022, online: Meeting approved Annual Report 2021, Budget results 2021, Workplan 2022, and fundraising guidelines for the Network. Preparations for the elections for the next Steering Group were informed. The meeting took note of minor updates to the Strategy, the result of a midterm internal review.

General Assembly, 16 March 2022, online: Meeting adopted Annual Report 2021, Budget results 2021, Workplan 2022, Budget 2022, and fundraising guidelines for the Network. The General Assembly assigned the Secretariat and Steering Group to enable exchange on child victims of war, and on scaling Barnahus up nationally.

Steering Group, 19 October 2022, online: Meeting approved one new member application, and discussed preparations for the first Barnahus Forum. It also discussed the main assignments from the General Assembly, to enable exchange on child victims of war, and how to expand Barnahus nationally with an eye on quality.

ADMINISTRATION

The year featured the first election of the steering group, minor updates to the 2020-2025 Strategy to reflect recent developments, and the continuation of administration routines.

NETWORK SUPPORT

COURSES

The Network developed a training on multidisciplinary teamwork this year which features lectures, discussions, and group work using a tabletop exercise. This training was tailored and delivered to several countries this year, either on a contractual basis or within projects. Additional courses or lectures were provided on a contractual basis.

ON-GOING PROJECTS

The following projects were launched last year or previously.

EXCHANGE

THE FIRST BARNAHUS FORUM

The first Barnahus Forum was held in Stockholm 5 December 2022. We had a vibrant exchange of information, tools, contacts, and inspiration that will no doubt fuel your momentum in establishing Barnahus and achieving excellence in practice. A **photo album** from the day is ready, with some highlights presented below.

The feeling in the plenary was electric – this being the first time we could meet in person since launching the Network in 2019.

Definition – Includes supporting network members via in-person and virtual exchange, including at the Barnahus Form, General Assemblies, study visit, and 1:1 networking opportunities.

Purpose - Enabling a vibrant exchange of knowledge and practices among members and with key stakeholders.





Child delegates from Bulgaria, Germany and Ireland interviewed Grzegorz Poznański, Director General, Council of the Baltic Sea States Secretariat, and Bragi Guðbrandsson, member of the UN Committee on the Rights of the Child, initiator of the Barnahus model. Their conversation covered the past and future development of Barnahus, common challenges.



In her <u>video</u> address, Dr. Maalla Mjid, Special Representative of the Secretary-General on Violence against Children urged that quality matters, that standards must be updated to reflect the latest research into what works best in supporting child victims of violence, and that

children's views in this regard can be a source of inspiration and guidance within and beyond the member countries.



In her <u>video</u> address, Dubravka Šuica, Vice-President of the European Commission for Democracy and Demography, she thanked the members for their daily commitment to preventing and fighting violence, with and for children. She noted that the day's discussions will give input to the European Commission's work to support integrated child protection systems in member states. She also noted that a proposed EU center for preventing child sexual abuse can support the broader implementation of Barnahus.



In 16 breakout sessions, the members explored the role of Barnahus managers, considerations for scaling up Barnahus, children affected by armed conflict, adapting to online sexual abuse cases, children with harmful behavior, the importance of medical evaluations for every child, and much much more. With more than one third of the participants having an

active role in one or more breakout sessions, this day really was by the members and for the members.

> "This was a really inspiring and informative conference. The informal chats and comments from the floor during each session were as important as the presentations and prepared interviews."



Several of the sessions put the ideas and inspiration from the day into action by gathering feedback on the Barnahus Quality Standards. Considering the fast pace of developments since the Standards were published in 2017, the members harnessed this opportunity to ensure that they remain clear, concise, and that important elements aren't missing. Children also presented their feedback.



At the mingle, the choir from Stockholm's Music High School performed a <u>luciatag</u>, which carries on a tradition started at our first <u>European Barnahus exchange in Linköping</u>, Sweden in Winter 2016. Members made memories at the photo booth, by building a PROMISE city with Legos, and other ice breaking and teambuilding activities.

"Yesterday's conference for Barnahus in Europe really moved me. What a pleasure to be able to join this journey for several years now. Completely unimaginable how the Barnahus idea has spread to all corners of Europe. It warmed my heart to meet so many friends from our large Barnahus family."

Some members managed to snag one of the limited spots on the highly coveted study visits to Barnahus Stockholm and Barnahus Linköping, which took place Tuesday. An excellent opportunity to continue networking, and to build on the knowledge and inspiration gained from the day.



In the days to come, the Network's secretariat will be analysing the notes to see what gaps in tools, experience, and knowledge that the Network should work to fill.
